So just to give an overview of our financial position, it's been another good year for U KG. So obviously 20/20 was a challenging period as was 2021. But over the last couple of years, our finances have been steadily recovering as a as an organisation. So this year we've been able to do some more exciting things in terms of investing in our mission and strategy. So we've relaunched the innovation awards and so we've been able to make some more grants to a number of organisations and there's details

in our annual report. We undertook an EDI review. So looking at what we can do as an organisation to become more diverse and to foster a quality diversity and inclusion within our membership. And we've also commissioned a piece of conference research being undertaken by Information Power just to make sure that our conference remains valuable and relevant into the into the future. So it's been really positive to be able to invest in in some of those areas and alongside doing that we've been able to continue

making a surplus this year. So we spent a bit more than in 2022 but our revenues have continued to exceed our expenditure. So again that's a strong financial result for the last year and we've taken some steps just to improve how we control our finances and some of you will know if you have a mortgage or anything. Interest rates have been have been going up and that's actually been a positive for us at U KG. So we have significant cash reserves and we just been making sure that we continue to earn interest

on those and reinvesting those, those monies back into our community. And of course we went

back to a fully in person conference this year and will be and last year and the conference is probably the most important thing for our financial health as a as an organisation. So that being successful was a huge positive in 2023 and we're very much expecting the same again for 2024. Delicate numbers are looking really positive, lots of sponsors and exhibitors. So that puts us in a very strong

And I'd also like to thank Claire Grace, webinar officer and the trustee, who has supported 2 webinars this year.
