

# The Code 2018 - 2024

- ▶ Informed by Critical Cataloguing movement, DEI and decolonisation
- ▶ International community initiative - inclusive and open
- ▶ Recognises special responsibilities of cataloguers and metadata managers
- ▶ Complements professional codes of ethics
- ▶ Endorsed by ALA (2021), CILIP (2022), CFLA-FCAB (2024)
- ▶ Practical tool for reviewing ethical policy and practice
- ▶ Encourages advocacy for and by cataloguers/metadata managers
- ▶ Intended for use by ALL metadata stakeholders - not just libraries

# Code includes 10 statements - our joint ethical responsibilities

- ▶ Access to resources and metadata
- ▶ Acknowledging bias
- ▶ Advocacy
- ▶ **Collaboration**
- ▶ Critically applying standards
- ▶ Diversity, equity, and inclusion
- ▶ **Education and training**
- ▶ Respect for agent privacy and preferences
- ▶ Responsibility and transparency
- ▶ **Understanding and meeting user needs**

8. We insist on diversity, equity, and inclusion in the workplace. We promote education, training, equitable pay, and a fair work environment for everyone who catalogues ...

- ▶ Create, disseminate, enrich and preserve metadata to support search, discovery and access (and sales!)
- ▶ Reflect cultural diversity in our publishing output, metadata and workforce

- ▶ Embed ethical cataloguing in our workforce development - good for Society and good for business
